PRESENTATION: THIRD AVENUE BYPASS IN KETCHIKAN, ALASKA

The new Third Avenue Extension will be nearly a mile long, traversing a rugged, southwest facing mountain slope above the City of Ketchikan in Southeast Alaska. Built to relieve traffic congestion along Tongass Avenue, the new roadway is challenging due to residences immediately down slope, extremely steep terrain, and difficult access. The central segment of the project crosses a 400-foot wide landslide, a 200-foot tall rock escarpment (White Cliff), and a long talus slope. Construction began in August of 2002 and included the use of roller compacted concrete in a 1000 foot long and 90-foot tall embankment in the difficult central segment. A cut slope through White Cliff will remove 60,000 cubic yards of rock, with slopes over 115 feet in height using a combination of conventional rock blasting and a mechanical "Roadminer".

Mike Meyer, P.E. is a senior associate engineer with Landslide Technology. He has been with the

firm since 1991 and holds a B.S. in Geological Engineering and an M.S. in Geotechnical Engineering from Washington State University. Larry Pierson is a graduate of UCLA with over 25 years of transportation-related experience as an engineering geologist, much of this dedicated to rockfall mitigation and rock slope investigation and design. Larry was the principal rock slope designer for 15 years at ODOT. He contributed as the area expert on structural geology; and rock slope investigation, analysis and design. He has authored or co-authored several publications including numerous technical manuals, research papers, and geotechnical articles.
